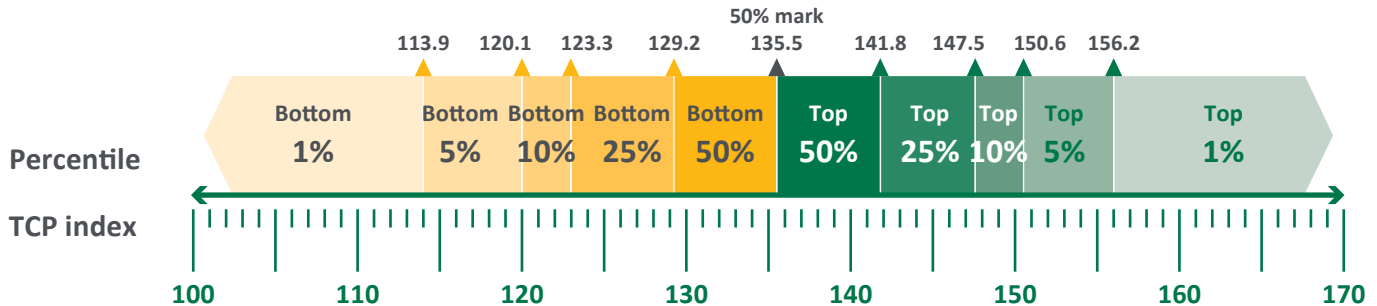

THE NEW TCP INDEX

The TCP Index has been created to assist producers to achieve both gains in their major production traits, such as post-weaning weight and muscling, as well as ensuring consumer satisfaction from lamb is maintained through focusing on key eating quality traits such as shear force (tenderness) and intramuscular fat (marbling).

The TCP Index, unlike Carcase Plus, is on a scale that is aligned with other Sheep Genetics' indexes and is represented in economic terms with a unit index reflecting an additional dollar per ewe joined per year. To assist in comparing rams, Sheep Genetics recommends using a percentile band table as reference. The figure below, which is based on the percentile band table, highlights the TCP index value for significant percentiles for the 2018 drop animals.

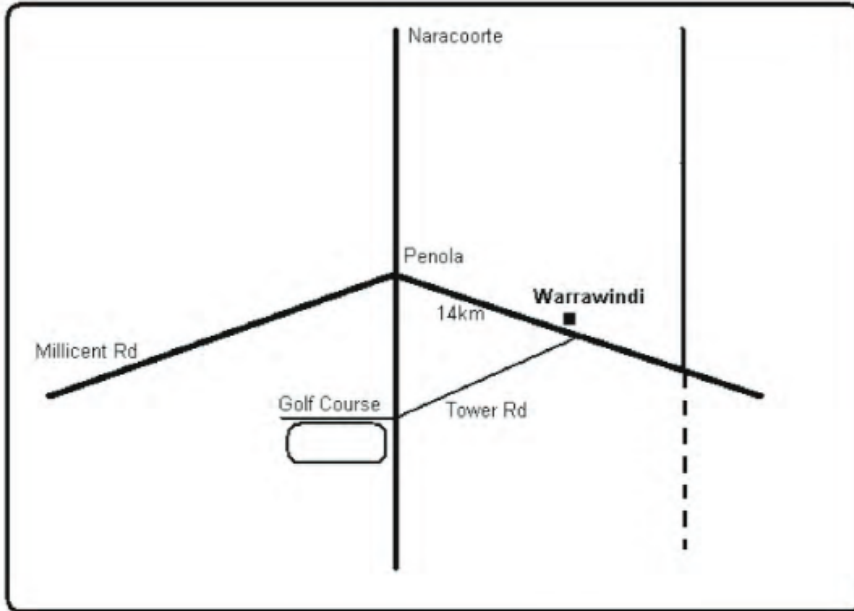
